Your completed ballot will be filed with the appropriate county clerk. Once filed, the county clerk is responsible for maintaining the official ballots and counts the vote. Voting machines will not be present in every polling place, therefore, official ballots will be counted. Results will be reported to the Elections Division as soon as possible, but it may take several days. There will be no oral or manual recount. No record of your vote will be kept by the Board of Elections. The Board of Elections is not a prosecutorial agency. An individual may not be prosecuted for a failure to complete and return the application. In the event that an application is returned incomplete, the applicant should immediately notify the Board of Elections. A newly elected official is permitted a period of time to ascertain the necessity of filling out and returning the application. A newly elected official may petition the Board of Elections to fill out the form based on an election occurring after she assumes office. Any challenge for improper completion of the form should be filed with the Board of Elections within 10 days of the official assuming the office. Electronic filers are required to make available their electronic security card and supporting information to the Board of Elections for the time period required for processing the application. The Board of Elections shall not be responsible for the loss of any electronic ballot between the time the electronic filer is prompted to make available their electronic security card and the time the application is completed. The aims of this study were to compare the safety and efficacy of bivalirudin versus heparin in patients undergoing percutaneous coronary intervention (PCI). The HORIZONS-AMI trial (Harmonizing Outcomes with Revascularization and Stents in Acute Myocardial Infarction) randomized patients undergoing PCI to bivalirudin or unfractionated heparin (UFH). The primary endpoint was a composite of major bleeding, in-hospital death, and all-cause mortality at 30 days. Of 3048 patients randomized, 2441 received bivalirudin and 706 received UFH; of these, 2571 and 695 patients had their primary endpoint outcomes assessed at 30 days, and were included in this study. Compared with UFH, the composite endpoint was less common in the bivalirudin group (9.9% f678ea9f9e
